RULES AND REGULATIONS

1. This tournament is certified by USBC, certification #81204. Entry is open to all USBC female members with a 2011-12 local adult membership in the **4-Rivers USBC Association**.
2. Competition will be conducted in handicapped **TEAM, DOUBLES and SINGLES** events at **Town 'N Country Lanes, 603 Alberta Lane, Washington, MO 63090 • Phone (636) 239-2000 • FAX (636) 239-9069**.
 - a. **TEAM squads** are to be held at **12:30 PM** on **Saturdays, April 14 and 21, 2012** and on **Sundays, April 15 and 22, 2012**.
 - b. **DOUBLES & SINGLES squads** are to be held at **4:00 PM** on **Saturdays, April 14 and 21, 2012** and on **Sundays, April 15 and 22, 2012**.
 - c. **Additional squads may be added, or deleted, if needed, at the Tournament Director's discretion** and will be posted on the www.4riversusbc.com website.
3. The TEAM event will be three (3) games bowled by a team of four (4) female bowlers. The DOUBLES & SINGLES will be a combined event where the bowlers will bowl only three (3) games and the scores will be used for both DOUBLES event and SINGLES event. A bowler's first score in the TEAM event and in the combined DOUBLES & SINGLES event will count towards the optional 6-GAME ALL-EVENTS. The Team captain (or bowler) will be given starting lane assignment upon check-in prior to each Events' squad time.
4. An eligible USBC female bowler may enter the combined DOUBLES & SINGLES without a Doubles partner. A bowler must enter the TEAM and the combined DOUBLES & SINGLES to be eligible to enter the optional 6-Game All-Events.
5. Bowlers may enter more than once (as space in regularly scheduled squads is available). However, the 4-bowler Team must have at least 2 different female members to qualify as a different Team. A Team can only qualify for prize monies once. A bowler must compete with a different Doubles partner to qualify for prize monies in that event more than once. A bowler can qualify for prize monies in Singles only once. The optional 6-GAME ALL-EVENTS entry must be paid at time of the bowler's first entry.
6. **ADVANCED REGISTRATION IS RECOMMENDED**. All entries will be scheduled according to date received by the Tournament Director. No entries will be scheduled without FULL payment of ALL entry fees. Entries will remain open as long as lanes are available and will be accepted up to 10 minutes prior to each squad times. Entry fees will not be refunded after the scheduled squads start times.
7. **ENTRY FEE**. Each Event is **\$15.00 per person** (\$9.00 Lineage + \$1.00 Expenses + \$5.00 Prize Fund). NOTE: The DOUBLES & SINGLES is a combined event with one \$15.00 entry fee. OPTIONAL: There is an additional entry fee of **\$3.00 per bowler** for each optional 6-GAME ALL-EVENTS entry and is included in the Prize Fund. The Prize Fund is returned 100%. **ALL FEES MUST ACCOMPANY ENTRY FORM**.
8. **AVERAGES**. Averages shall be the highest adult USBC sanctioned league average of at least 21-games or more for the 2010-11 season (includes sanctioned 2011 Summer leagues). If there is no qualified USBC average for 2010-11, a bowler must use the highest average with at least 12-games or more in a current 4-Rivers USBC league, as of the squad time bowled. If an average is not verifiable on www.bowl.com, the Official Averages & Yearbook for the 2010-11 Season, or by current leagues' standing sheets, the bowler must use an average of 220 in each Event.
9. **HANDICAPS**. For each Event, the tournament will use 90% of the difference between the bowler's average and 220. Bowlers with an average of 220 or more must use the scratch scores bowled in each Event. NO bowler will be given a negative handicap.
10. **CASH PRIZES**. The tournament guarantees \$700.00 to be awarded in cash prizes. The 1st Place winners of TEAM, DOUBLES and SINGLES will be awarded \$100.00 to each Champion bowler. Other cash prizes will be awarded to participants at a prize ratio at one in three entries in each Event. In the case of ties, the cash prizes for the positions affected will be equally divided.
11. All bowlers must show their current USBC membership card at check-in. Duplicate cards can be printed from www.bowl.com. Check-in will begin 30-minutes prior to each squad time. Substitutes must be presented to the Tournament Director prior to check-in.
12. Tardy bowlers will start to bowl in the frame in progress at the time of their arrival. No pins are awarded for missed frames.
13. USBC Rules 300c and 319 will apply. All rules not covers here will be covered by USBC tournament rules.
14. All disputes and protests shall be handled by the Tournament Director. Contact **Roberta Cano, Association Manager** at **573.484.4346** or association.manager@4riversusbc.com. The decision of the Tournament Director shall be final unless an appeal is filed within 72-hours in accordance with USBC rules.
